

# Milo International Junior All Stars Bowling Championship 2010

Sanctioned By Malaysian Tenpin Bowling Congress & Asian Bowling Federation

# 1. OBJECTIVE

The objective of this Tournament is to foster and promote goodwill, friendship and sportsmanship amongst the local and foreign youth bowling fraternity.

# 2. ORGANISATION & SANCTION

The Milo International Junior All-Stars Bowling Championship is organized by Sunway Megalanes and sanctioned by Malaysian Tenpin Bowling Congress, Asian Bowling Federation and World Tenpin Bowling Association. MTBC and ABF playing rules and regulations shall apply on matters not covered therein.

# 3. ELIGIBILITY

All current MTBC members of good standing and foreign bowlers accredited by their respective Congress/ Federation/ Association who are born in 1987 or after are eligible to participate in this Championship.

# 4. AVERAGES

For local participants, grading will be based on Junior Circuit and the official averages of MTBC (74) and bowlers without established average must produce written confirmation of their averages from their respective Associations. Overseas bowlers must submit a certification or proof of their averages as attested by their officials. Lower grade participants are allowed to bowl in the Open.

## 5. ENTRY FEES

All entries must be submitted with the relevant fees. No refund will be allowed.

## 6. **REGISTRATION FEES**

RM90.00 per bowler (one time payment)

## 7. SINGLES

RM90.00 per attempt for 3 games. The first attempt must be a Singles event. 15 & under and 12 & under category does not need to bowl for Singles event.

## 8. MASTER QUALIFYING

Open and Graded category - RM90.00 per attempt of 3 games. 15 & Under – RM50.00 per attempt of 3 games 12 & Under – RM35.00 per attempt of 3 games

## 9. SQUAD TIMES

If preferred squad times indicated on the entry forms are not available, the Tournament Directors or Assistants reserve the right to reallocate squad times at their discretion. The Tournament Directors reserve the right to open additional squads.

# **10. REGISTRATION OF BOWLING BALLS**

It is the bowlers' responsibility to ensure that all bowling balls used during the Tournament are verified for correctness of weight and other specifications. If in doubt, the ball may be verified by the Tournament Technical Committee. The Tournament Technical Committee reserves the right to recall any ball(s) for inspection at any time.

## **11. TIE BREAKING PROCEDURES**

- (i) When a tie occurs for the last place in the Qualifying (oversea / local pool), a one game roll-off shall be held to determine the positions.
- (ii) If a tie exists in (10.i) after the tie-breaker, a one ball roll-off will be utilized and/or repeated until the tie is broken.

(iii) When a tie occurs for the Final (Semi Final), a one ball roll-off will be utilized and/or repeated until the tie is broken.

# 12. MASTER'S FINALS

# (i) BOYS GRADED AND GIRLS GRADED

This event is open to boys averaging 185 and below and girls average of 175 and below. The fee is RM250.00 for both Boys and Girls finalist. The top 32 Boys and top 16 Girls qualifiers will bowl 10 games scratch, total pinfalls to decide the winners. Last squad for qualifying is on 15th December 2010 at 9:30pm. Final is on Friday, 16<sup>th</sup> December 2010.

# (ii) BOYS OPEN AND GIRLS OPEN

The fee is RM350.00 for both Boys and Girls finalist. The top 44 Boys (Defending Champion, 12 local pool + 12 overseas pool + 16 mixed pool + 3 desparado squad) and top 36 Girls (Defending champion + 11 local pool + 11 overseas pool + 11 mixed pool + 2 desparado squad) qualifiers will bowl 10 games. The top 4 finishers based on total pinfalls shall advance to the step-ladder. The 4<sup>th</sup>, 3<sup>rd</sup> and 2<sup>nd</sup> position bowler will bowl one game on a pair of lane. The lowest pinfall will declared as 4<sup>th</sup> Position. The 2<sup>nd</sup> lowest pinfall will declared as 3<sup>rd</sup> Position. The highest pinfall among of the 3 bowlers will proceed to challenge the 1<sup>st</sup> position bowler in a one plus one game step-ladder grand finals. In the event the 1<sup>st</sup> position bowler wins the 1<sup>st</sup> game, he/she will be declared the Champion. If the 1<sup>st</sup> position bowler looses the 1<sup>st</sup> game, there will be one more game (sudden death) roll off on scratch to decide the Champion. Final is on Saturday, 17<sup>th</sup> December 2010. Reserves will be called 15 minutes before roll-off.

#### BOYS OPEN FINAL - ROLL OFF AT 8.30AM GIRL OPEN FINAL – ROLL OFF AT 1.00PM

## (iv) 12 YEARS & UNDER

The fee is RM 100.00. The top 18 boys and top 18 girls will bowl 8 games scratch, total pinfalls to decide the winners. Last squad for qualifying is on 12<sup>th</sup> December 2010 at 7:00pm. Final on 13<sup>th</sup> December 2010.

# (v) 15 YEARS & UNDER

The fee is RM 100.00. The top 18 boys and top 18 girls will bowl 8 games scratch, total pinfalls to decide the winners. Last squad for qualifying is on 13<sup>th</sup> December 2010 at 7:00pm. Final on 14<sup>th</sup> December 2010.

# 13. AWARDS

Prizes in the form of Cash Vouchers will be awarded to the winners.

## **14. VERIFICATIONS OF SCORES**

It is the bowlers' responsibility to ensure that the correct score for each game is recorded in the official score sheet by signing on the official score sheet.

## **15. PROTEST**

- (i) **Scores** : Must be submitted in writing to the Tournament Directors or their Assistants within 12 hours of the event. No protest made after the prize presentation will be entertained.
- (ii) **Eligibility** : Must be submitted in writing to the Tournament Directors or their Assistants within 12 hours of the first infringement.
- (iii) **Foul** : Must be brought to the attention of the Lane Marshall before the delivery of the next ball. No complaints made after the 2<sup>nd</sup> ball has been bowled shall be entertained.

## 16. SPECIAL NOTES

(i) The Tournament Directors, or, in his absence, his appointed official on duty, reserves the right to accept or reject any entry as deem fit. Any matters arising which are not covered in these Rules and Regulations will be decided by the Tournament Directors. The decision of the Tournament Directors shall be final. Such appeal should be made in writing and within 12 hours of the decision by any of the above.

# (ii) PERFECT GAME AWARD IS FOR THE 1<sup>ST</sup> BOWLER TO ROLL OFF A PERFECT GAME AT ANY ONE OF THE FINALS.
