## 1. Organization \& Sanction

1.1 This International Bowling Championship is organized by the Singapore Bowling Federation and sanctioned by ABF and World Bowling. World Bowling Playing Rules and Regulations shall apply on matters not covered herein.
1.2 This tournament will be held from 16 - 30 June 2019 at SingaporeBowling@ Rifle Range.
2. Eligibility
2.1 All current members of SBF Member Clubs of good standing and foreign bowlers accredited by their respective Congress/Federation/Association are eligible to participate in this tournament. Bowlers will be classified based on their country of citizenship.
2.2 (a) The SBF official average as at 31 December 2018 for local bowlers shall be used for purposes of classification, subject to the bowlers having completed a minimum of 18 games. Bowlers without the minimum requirement of 18 games must submit certified confirmation showing the scores of ALL GAMES bowled in SBF sanctioned leagues and tournaments.
(b) Overseas bowlers must submit a certification or proof of their averages as attested to by the officials of their respective Congress/Federation/Association.
2.3 Irrespective of average, a bowler who has won in a Graded ' $B$ ' or ' $A$ ' Masters in an SBF or ABF/World Bowling sanctioned tournament in year 2017, 2018 and 2019 is not allowed to participate in a similar and/or lower graded division of this tournament bur can participate in a higher grade.
It is the responsibility of the bowler to ascertain whether he/she is qualified to bowl in the graded divisions under this rule.

## 3. Entry Fees

3.1 The Registration Fee is chargeable based on the division that the bowler wishes to participate in. Should the bowler wish to participate in more than one division, the fee will be charged based on the higher priced division.
(Example: Registrant wishes to take part in Under 15 Girl \& Women's Graded Division, she will have to pay the Registration Fee of Women's Graded i.e \$80).
This will entitle a registrant to a souvenir of the tournament and an invitation to the Appreciation Night.

3.2 No refund shall be made after an entry has been registered and accepted.
3.3 A participant who fails to show up or is late for the scheduled squad shall be disqualified from participation in that squad and the entry fee forfeited.

## 4. Classification/Format of play

4.1 Men's Open: All male bowlers, regardless of average, are eligible to participate in this division.
4.2 Women's Open: All female bowlers, regardless of average, are eligible to participate in this division.
4.3 Men's Graded A: All male bowlers with AN AVERAGE OF 200 AND BELOW are eligible to play in this division.
4.4 Men's Graded B: All male bowlers with AN AVERAGE OF 180 AND BELOW are eligible to play in this division.
4.5 Women's Graded: All female bowlers with AN AVERAGE OF 190 AND BELOW are eligible to play in this division.
4.6 Senior Division: All male and female bowlers 50 years and above (Born in year 1969 and before).
4.7 Youth Division: All boys and girls who are 21 years of age and below (Born in year 1998 and after).
4.8 Under 18 Division: All boys and girls who are 18 years of age and below (Born in year 2001 and after).
4.9 Under 15 Division: All boys and girls who are 15 years of age and below (Born in year 2004 and after).
4.10 Under 12 Division: All boys and girls who are 12 years of age and below (Born in year 2007 and after)
4.11 A lower grade bowler playing in a higher grade will have his/her score classified according to the grade entered for.
5. Masters Event

The qualifying scores will be based on best 2 attempts (total of 6 games) from the Masters Qualifying ( 3 games per qualifying attempt) in the respective divisions.
All the top qualifiers based on the Masters Qualifying score, will be listed on the Championship Result Board from the start of the qualifying rounds till the end of the last squad.
5.1 It is the responsibility of the qualifiers to confirm their fixtures and/or to check for any changes in the schedule, 24 hours before their Masters Finals roll-off.
5.2 For Men's \& Women's Open Division -
(a) In the event the Defending Champion from the Men's \& Women's Open division does not defend the title, the vacancy will go to the Local / Overseas Pool.
(b) In the event that a Masters Qualifier from the LOCAL Pool being absent, the vacancy will be filled from the Local Pool Reserve list.
(c) In the event that a Masters Qualifier from the OVERSEAS Pool being absent, the vacancy will be filled from the Overseas Pool Reserve List.
(d) In the event that a Masters Qualifier from the LOCAL/OVERSEAS Pool being absent, the vacancy will be filled from the Local/Overseas Pool Reserve List.
(e) In the event that a Masters Qualifier from the DESPERADO Squad being absent, the vacancy will be filled from the DESPERADO Squad, next bowler on list (i.e. 5th position in Men's Graded 'A' Division, 4th position in Men's Open Division, 3rd position in Women's Open Division).

## 6. Tie - Breaking Procedures

6.1 When a tie is registered in the Masters' Qualifying event, the player with the highest high game, in the qualifying series, shall be the winner. If this still ends in a tie, the next high game will be counted, and/or repeated until the tie is broken.
6.2 When a tie is registered in the Masters Final of all Divisions (except Open Division), the player with the highest game shall be the winner. If this still ends in a tie, the next high game will be counted, and/or repeated until the tie is broken.
When a tie is registered in the Open Division's Masters, Semi-Final and Step-Ladder Grand Final, a one-ball roll-off shall be used, and/or repeated until the tie is broken.
7. Substitution

Substitutions may be allowed provided it is reported to the Tournament Committee and duly approved by at least 30 minutes before the time of play.
8. Check-in Procedure - Masters Event

All finalists are to check-in personally at the tournament desk at least 30 minutes before the scheduled time for the Masters Event, failing which he/she will be disqualified and the respective reserve(s) will be called.

## Calls will be made as follows:

1st Call: 3 minutes prior to Check-in time
$2^{\text {nd }}$ Call: 2 minutes prior to Check-in time
$3^{\text {rd }}$ Call: 1 minute prior to Check-in time
The clock in the bowling centre will be the official timepiece.

## 9. Masters Final

### 9.1 Men's Open Masters Final

Round 1 - Defending Champion, $5^{\text {th }}$ to $14^{\text {th }}$ Local qualifiers (10), $5^{\text {th }}$ to $14^{\text {th }}$ Overseas qualifiers (10), Top 12 Qualifiers from Local / Overseas Pool, Top 3 Qualifiers from Desperado Squad. Total 36 Finalists will bowl 8 games.
Round 2 - Top 16 bowlers from Round 1 , $1^{\text {st }}$ to $4^{\text {th }}$ Local qualifiers (4), $1^{\text {st }}$ to $4^{\text {th }}$ Overseas qualifiers (4). Total 24 Finalists will bowl 8 games.
Round 3 (Semi-Final) - The $4^{\text {th }}, 3^{\text {rd }}$ and $2^{\text {nd }}$ placed bowlers will bowl one game each. The winner with the highest score will qualify to meet 1 st placed bowler in the stepladder grand finals.
Round 4 (Step-Ladder Grand Final) - The winner from Round 3 and 1 st placed bowler will bowl one game each. In the event the $1^{\text {st }}$ placed bowler wins the $1^{\text {st }}$ game, he will be declared the Champion. If the $1^{\text {st }}$ placed bowler loses the $1^{\text {st }}$ game, there shall be a one game roll off on scratch to decide the Champion.
Bowlers who lose in $1^{\text {st }}$ match of the Step Ladder Grand Finals can only move up or down one position from their original rank prior to their respective match (For example, a bowler who came in second and loses the $1^{\text {st }}$ match will drop to third position).
9.2 Women's Open Masters Final

Round 1 - Defending Champion, $4^{\text {th }}$ to $10^{\text {th }}$ Local qualifiers (7), $4^{\text {th }}$ to $10^{\text {th }}$ Overseas qualifiers (7), Top 11 Qualifiers from Local / Overseas Pool, Top 2 Qualifiers from Desperado Squad. Total 28 Finalists will bowl 8 games.
Round 2 - Top 12 bowlers from Round 1 , $1^{\text {st }}$ to $3^{\text {rd }}$ Local qualifiers (3), $1^{\text {st }}$ to $3^{\text {rd }}$ Overseas qualifiers (3). Total 18 Finalists will bowl 8 games.
Round 3 (Semi-Final) - The $4^{\text {th }}, 3^{\text {rd }}$ and $2^{\text {nd }}$ placed bowlers will bowl one game each. The winner with the highest score will qualify to meet 1 st placed bowler in the stepladder grand finals.
Round 4 (Step-Ladder Grand Final) - The winner from Round 3 and $1^{\text {st }}$ placed bowler will bowl one game each. In the event the $1^{\text {st }}$ placed bowler wins the $1^{\text {st }}$ game, he will be declared the Champion. If the $1^{\text {st }}$ placed bowler loses the $1^{\text {st }}$ game, there shall be a one game roll off on scratch to decide the Champion.
Bowlers who lose in $1^{\text {st }}$ match of the Step Ladder Grand Finals can only move up or down one position from their original rank prior to their respective match (For example, a bowler who came in second and loses the $1^{\text {st }}$ match will drop to third position).
9.3 Men's Graded A Masters Final

Top 20 finalists and Top 4 from Desperado Squad. Total 24 finalists will play 8 games scratch, total pin-falls to decide the winners.
9.4 Men's Graded B Masters Final

Top 20 finalists will play 8 games scratch, total pin-falls to decide the winners.
9.5 Women's Graded Masters Final

Top 16 finalists will play 8 games scratch, total pin-falls to decide the winners.
9.6 Senior Masters Final

1st to 6th Men's qualifiers (6), 1st to 6th Women's qualifiers (6), Top 12 Qualifiers from mixed gender pool (12). Total 24 Finalists will bowl 8 games.

### 9.7 Youth Masters Final

Top 24 boy finalists and top 20 girl finalists will play 8 games scratch, total pin-falls to decide the winners.
9.8 Under 18 Masters Final

Top 24 boy finalists and top 18 girl finalists will play 8 games scratch, total pin-falls to decide the winners.
9.9 Under 15 Masters Final

Top 24 boy finalists and top 18 girl finalists will play 8 games scratch, total pin-falls to decide the winners.

### 9.10 Under 12 Masters Final

Top 24 boy finalists and top 18 girl finalists will play 8 games scratch, total pin-falls to decide the winners.
10. Bowler's attire

Bowlers are required to be properly and appropriately dressed for bowling. If, in the opinion of the Tournament Director a bowler is not appropriately dressed, he/she may not be permitted to bowl. Male bowlers must wear pants or slacks and are not allowed to wear sleeveless shirts and/or shorts, Bermuda's; female bowlers may wear skirts, shorts, pants, slacks or dress shorts.
MALE AND FEMALE BOWLERS ARE NOT ALLOWED TO WEAR JEANS.
In the event of TV coverage, it is the prerogative of the Tournament Manager to stipulate the attire to be worn.

## 11. Registration of Entries / Squad Times

11.1 Registration of Entries

Registration of entries (must be made in the following venue, no calls will be entertained):
The following will apply for locals:

- All Registration \& MQ chits must be filled up. Incomplete chits will be voided.
- Must be duly paid and slotted in
- No refunds for No-Show (applicable to all participants)
- No reservations will be entertained without paid chit submission
- Changes to time-slots will be permitted provided lanes have not been drawn for the time-slot requested and if there are vacancies for the preferred time-slot (applies to all participants)
- No refunds once chits are sold (applies to all participants)
11.2 Squad Booking Days

Entries will be accepted subject to the availability of lanes and squad times. The Tournament Committee reserves the right to accept or reject an entry, postpone, add/cancel any squad time. The tournament director reserves the right to reallocate squad times.
11.4 From 24 June 2019 onwards, priority will be given to overseas bowlers. Local bowlers can only play when vacancies arise. Reservations for local bowlers will not be allowed.
11.5 If preferred squad times indicated on the entry forms are not available, the Tournament Committee reserve the right to reallocate squad times at their discretion.
11.6 Desperado Squad (Men's / Women Open Division \& Men's Graded 'A' Division only) The Desperado squad will comprise of 1 game. Only bowlers who have a minimum of 4 MQ ATTEMPTS in their respective registered categories are eligible to compete in the Desperado Squad.
Top 3 Male and 2 Female Qualifiers from Open Division and the top 4 Male Qualifiers from Men's Graded 'A' Division shall qualify for the Masters Final. (There must be a Minimum of 6 registered entries in each category in order to proceed with the Desperado Squad).
When a tie is registered, a one ball roll-off will be used and if it still ends in a tie, it shall be repeated until the tie is broken.
12. Slow Bowling

Slow bowling is not allowed and bowlers must bowl when it is their turn to do so. Players preparing to step on the approach and deliver a ball shall have the following rights and obligations:
12.1 They may claim right of way only over a player moving to the approach on preparingto bowl on the lane immediately to their left.
12.2 They shall yield to a player moving to the approach or preparing to bowl on the lane immediately on their right.
12.3 They shall be ready to bowl when it is their turn and shall not delay the start of their approach or delivery if the lanes immediately adjacent to them on both the right and left are clear.
12.4 A player is given 30 seconds from the moment the previous bowler steps down from the approach to the time the ball leaves the hand of the bowler. Lane marshals will be given stopwatches to randomly check the timing of the bowlers in their delivery.
12.5 If a player does not observe the procedures outlined in clause 12, it may be construed as slow bowling. A player failing to observe these procedures shall be warned by an authorized tournament official as follows:
(a) A white card for the first offence (no penalty)
(b) A yellow card for the second offence (no penalty)
(c) Red card for the third and succeeding offence in any block of games, penalty shall be zero pin-falls for the frame.
13. Bowling balls
13.1 It is the bowler's responsibility to ensure that all bowling balls used during the tournament are verified for correctness of weight and other specifications conforming to World Bowling Rules and Regulations. The tournament director reserves the right to examine the balls used by the participants. Use of an illegal ball is grounds for disqualification and forfeiture of all games, prizes and standings aside from any other penalties that may be imposed.
13.2 Altering the surface of the bowling ball is only allowed before commencement/after completion of each game, provided they are made at the designated area and it must not delay the bowlers and the progress of the game.
14. Interrupted Game(s)
14.1 The tournament director may authorize the completion of a game and series on another pair of lanes when equipment failure on the lanes would delay the normal progress of the series. An interrupted game and series that cannot be completed must resume from the point of interruption.
14.2 In the event of the score of any game is lost and/or erased and cannot be recalled and/or traced due to power or equipment failure, the bowler concerned will be required to re-bowl a new game when the power supply resumes or equipment is repaired. However, all scores of completed games that have been recorded in the official score sheet shall remain unchanged.
14.3 Lane Breakdown

If a pair of lanes becomes unusable or unplayable before or during the squad games as determined by the tournament director or its assigned official, any available pair of lanes provided by the bowling centre shall be assigned to affected participant(s) or shall wait for the next available squad. In case of machine breakdown during the Masters, vacant lanes shall be assigned to affected finalists. Any interrupted game(s) or series must resume from the point (frame) of interruption. Practice throws (if any) shall be given at the discretion of the Tournament Director. In the event that a next available squad is offered in place, participants will be given the same amount of practice time as accorded to the rest of the squad.
In the event where the wait for rectification is more than 15 minutes on the same lanes, the affected bowler(s) will be entitled to 1 warm up shot on each lane once the fault is resolved.
Should a change of lane be required, the affected bowler(s) will be entitled to 2 practice throws on each lane.

## 15. Prizes \& Awards

15.1 Prizes in the form of Cash Vouchers, Gifts, Medallions, etc. will be awarded to the winners of the various categories. Bowling Center House Awards do not apply.
15.2 Perfect Game Award of $\$ \$ \$ 10,000.00$ CASH will be shared equally amongst bowlers who attain perfect games during the qualifying rounds (Daily Designated Squads). The Daily Designated Squad will be drawn before the 1 st qualifying squad of each day.
Foreign bowlers are liable for withholding tax on all prize monies received.
16. Protest
16.1 Eligibility

Protest involving eligibility or general playing rules must be submitted in writing to the tournament director within 24 hours of the game in which the infraction occurred, or before prize presentation, whichever is sooner. If no written protest is filed prior to the expiration period as stated above, the game or games shall stand as bowled. Each protest under this rule shall not be construed to cover a similar or previous violation.

### 16.2 All Other Protests

Protest involving the Masters Qualifying event must be lodged with the Tournament Committee in writing, not later than 2 hours after the completion of the squad in which the protest has arisen. When a protest involves the Masters Event of the Open Division (Men \& Women), such a protest must be lodged with the Tournament Committee on the spot, in any case before the commencement of the Step-Ladder Grand Finals. Protest involving the Step-Ladder Grand Finals must be brought to the attention of the Tournament Committee on the spot.
No protests will be entertained after the presentation of prizes.

### 16.3 Withholding of Prizes

When a protest is lodged involving the final positions in any event and pending the decision of appeals to either SBF or ABF/World Bowling, the Tournament Director reserves the right to withhold presentation of prizes for the event pending the outcome of the appeal.

### 16.4 Error in Scoring

The Tournament Officials immediately upon discovery of such errors will correct errors in scoring or calculation. Protests involving errors in scoring will only be entertained if such protests are brought to the attention of the Tournament Director or his appointed official on duty on the spot.
16.5 Fouls

Protest involving fouls must be brought to the attention of the Lane Marshall before the delivery of the next ball.
No protest will be entertained after the bowler has made his/her second delivery of the frame.
17. Verification of Scores

It is the bowler's responsibility to ensure that the correct score for each game bowled is recorded in the official score sheet by signing in the official score sheet, which will be used as the official score record. Once signed, the scores shall stand unless otherwise decided by the Tournament Committee. If the official score sheet is not signed for any reason, the Tournament Committee reserves the right to refuse acceptance of the score sheet.
18. Errors

Errors in scoring or in calculation must be corrected by a responsible tournament official immediately, upon discovery. The tournament director shall decide questionable errors. The time limit for registering protests on scoring errors shall be one hour from the end of the squad for each day of the tournament. Each protest under this rule must be specific in it and shall not be construed to cover a previous or similar violation.
19. Matters Not Provided For

The tournament director whose decision shall be governed by World Bowling General Rules \& Regulations, shall decide on any matter arising, which is not covered in these Rules \& Regulations. Such a decision shall be final, subject only to an appeal to be made in writing to Singapore Bowling Federation General Council within 24 hours of the decision of the tournament director.
20. Interpretation Clause
20.1 The Tournament Committee, reserves the right to accept or reject any entry as they deem fit.
20.2 Any matters arising that are not covered in these Tournament Rules and Regulations, will be decided upon by the Tournament Committee (through adoption of the World Bowling Playing Rules and Regulations). The decision of the Tournament Committee shall be final subject only to appeal to SBF, which must be made in writing within oneweek of the decision.

## 21. ABF Adjudication

Notwithstanding Rule \#20, an appeal may be submitted in writing to the Asian Bowling Federation through SBF within 30 days of SBF's decision for final adjudication.
