

3rd STORM SPINNER CUP 2025

Sanctioned By Malaysian Tenpin Bowling Congress & Asian Bowling Federation

1. OBJECTIVE

The objective of this Tournament is to foster and promote goodwill, friendship and sportsmanship amongst bowling fraternity.

2. ORGANISATION & SANCTION

The Storm Spinner Cup 2025 is organized by Sunway Mega Lanes and sanctioned by Malaysian Tenpin Bowling Congress and Asian Bowling Federation. World Bowling Playing Rules as of September 2019 shall apply on matters not covered herein.

3. ELIGIBILITY

Specially for Spinner Bowlers only. All current MTBC members of good standing and foreign bowlers accredited by their respective Congress/ Federation/ Association are eligible to participate in this Championship. All overseas participants must obtain clearance from their respective National Tenpin Bowling Association.

7. FORMAT OF PLAY

The scoring shall be the World Bowling Current Frame Scoring System.

Qualifying of 4 games	Best of 2 squads
Top 40 bowlers to finals	8 games
Top 16 bowlers	Knock out – RACE TO 2
Top 8 bowlers	Knock out – RACE TO 2
Top 4 bowlers	Knock out – RACE TO 2
Top 2 bowlers	Knock out – RACE TO 2

Race to 2; In the event of a tie in points, total pinfall will decide the winner. In the event of the same total pinfall, a 1-ball roll off will decide the winner.

8. REGISTRATION OF BOWLING BALLS

It is the bowlers' responsibility to ensure that all bowling balls used during the Tournament are verified for correctness of weight and other specifications. If in doubt, the ball may be verified by the Tournament Technical Committee.

The Tournament Technical Committee reserves the right to recall any ball(s) for inspection at any time. Usage of sliding powder is strictly prohibited. Puff balls, hand conditioners ad rosin bags are allowed but must keep behind the bowler's area.

- **8.1** Altering the surface of bowling balls is only allowed **before the start of each block** in qualifying.
- **8.2** For Knock Out Round Altering of bowling ball surface is only allowed before the start of the **first match**. Altering the surface of bowling ball during the match will result in disqualification.

Storm / Roto Grip / 900 Global bowling balls must be registered before semi-final knock out rounds to be eligible for the side category 1st to 4th Position x RM1000 prize.

9. TIE BREAKING PROCEDURES

- **9.1** When a tie occurs in **Master Qualifying**, a one ball roll-off with the higher pin count will determine the winner.
- **9.2** When a tie occurs in **Knockout Rounds (Race to 2)**, total pinfall of the 2 games will decide the winner. In the event of the same total pinfall, a 1-ball roll off will decide the winner.
- **9.3** When a tie is registered which will affect the awards of prizes, the prizes will be shared equally among the winners.

10. AWARDS

Prizes in the form of Cash Vouchers will be awarded to the winners.

11. VERIFICATIONS OF SCORES

It is the bowlers' responsibility to ensure that the correct score for each game is recorded in the official score sheet by signing on the official score sheet.

12. BOWLERS ATTIRE

Bowlers are requested to be dressed for their events with a sense of decorum.

13. PROTEST

- **13.1 Scores**: Must be submitted in writing to the Tournament Directors or their Assistants within 12 hours of the event. No protest made after the prize presentation will be entertained.
- **13.2 Eligibility**: Must be submitted in writing to the Tournament Directors or their Assistants within 12 hours of the first infringement.

14. SPECIAL NOTES

The Tournament Directors, or, in his absence, his appointed official on duty, reserves the right to accept or reject any entry as deem fit. Any matters arising which are not covered in these Rules and Regulations will be decided by the Tournament Directors. The decision of the Tournament Directors shall be final. Such appeal should be made in writing and within 12 hours of the decision by any of the above.
